



## License Agreement for NBI Optimizer®

**PLEASE READ CAREFULLY BEFORE USING THIS SOFTWARE PRODUCT:** This License Agreement ("Agreement") is a legal agreement between (a) you ("Licensee") and (b) IDS Infrastructure Data Solutions, Inc. ("IDS"), a corporation with a place of business at 2 Research Drive, Suite 150, Regina, Saskatchewan, S4S 7H9, Canada. This Agreement governs your use of NBI Optimizer® Online Services made available by IDS.

**BY USING NBI Optimizer®, (1) YOU AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT AND (2) YOU REPRESENT THAT YOU ARE OF THE LEGAL AGE OF MAJORITY IN YOUR STATE, PROVINCE JURISDICTION OF RESIDENCE AND, IF APPLICABLE, YOU ARE DULY AUTHORIZED BY YOUR EMPLOYER TO ENTER INTO THIS CONTRACT. IF YOU DO NOT ACCEPT THE TERMS, DO NOT USE THE SOFTWARE PRODUCT.**

1. **GRANT OF LICENSE.** IDS grants to Licensee a personal, nonexclusive, nontransferable, worldwide license solely to access and use of NBI Optimizer® provided that: (a) the applicable license fees have been paid, (b) software services are used by Licensee or Licensee's Named Users, and (c) software is used for Licensee's own internal use, in accordance with this Agreement and as authorized by IDS.
2. **PROVISION OF NBI Optimizer® ONLINE SERVICES.** IDS grants you the following non-exclusive rights provided you agree to and comply with all terms and conditions of this Agreement:
  - a. **Use.** You may access NBI Optimizer® Online Services from your computers. IDS will provide customer support in accordance with its standard customer support policy and any additional support Licensee may purchase. IDS will use commercially reasonable efforts to ensure that Online Services will not transmit to Licensee any Malicious Code. IDS is not responsible for any Malicious Code that was introduced to Online Services through Licensee's account.
  - b. **Prohibited Use.** Licensee shall not use the Online Services to store or transmit any Malicious Code. Licensee shall not attempt to reverse engineer any part of NBI Optimizer®, to breach any security or authentication measures used by NBI Optimizer®, or to test the vulnerability of the Software. Licensee is responsible for any claims against IDS arising from Licensee's noncompliance with any prohibitions.
  - c. **Service Interruption.** Licensee's access to NBI Optimizer® Online Services may be interrupted or become temporarily unavailable, with or without prior notice, due to system failure, unanticipated or unscheduled downtime, or other events beyond the reasonable control of IDS. IDS provides Licensee with a Level of Service guarantee, as per a Service Level Agreement (SLA). IDS is not responsible for any damage, liabilities, losses (including loss of data and profits), or any other consequences that Licensee or any Licensee Named Users may incur as a result of any interruption to NBI Optimizer® Online Services.
  - d. **Reservation of Rights.** NBI Optimizer® is licensed, not sold, to you by IDS. IDS owns all right, title and interest in and to NBI Optimizer® and reserve all rights not

expressly granted to you in this Agreement. You agree to refrain from any action that would diminish such rights or would call them into question.

3. **ADDITIONAL SOFTWARE.** This Agreement applies to all upgrades or updates supplements to the original Software provided by IDS.
4. **INTELLECTUAL PROPERTY RIGHTS.** All intellectual property rights in NBI Optimizer® are owned by IDS and are protected by law, including but not limited to copyright, trade secret, and trademark law, as well as other applicable laws and international treaty provisions. Licensee shall not remove any IDS logos or other attribution associated with any use of Online Services.
5. **Licensee's Responsibilities.** Licensee shall be responsible for Named Users' compliance with this Agreement. Licensee and Licensee's Named Users are the only persons authorized to access NBI Optimizer® Online Services through Licensee's accounts. Named Users' login credentials are for designated named Users only and may not be shared among multiple individuals. Named Users login credentials may be re-assigned to new Named Users. Licensee's Named Users are responsible for maintaining the confidentiality of their login credentials and will notify IDS if Licensee becomes aware of any unauthorized use of Licensee's account or any other breach of security.
6. **LIMITATION OF LIABILITY.** Notwithstanding any damages that Licensee might incur, the entire liability of IDS under any provision of this Agreement shall be limited to the amount actually paid by Licensee for NBI Optimizer® subscription. In no event shall IDS be liable for any direct or indirect damages resulting from use of NBI Optimizer® Online Services.
